- One similar works each costing not less than Rs. 3,22,123/- Lakhs.

For the purpose of this clause similar work means development of garden, supply plants in /residential or non residential complex of prestigious nature like VVIP Building such as, RashtrapatiBhavan, Prime Minister Office, Parliament House, Baroda House etc.
