

Eligibility

1. Contractor having experience in horticulture development work, shall only be entertained.
 - a) Three similar works each costing not less than 40% of the estimated cost.
Or
 - b) Two similar works each costing not less than 60% of the estimated cost.
Or
 - (c) One similar works each costing not less than 80% of the estimated cost.

For the purpose of this clause similar work means developments of lawns and gardens etc.

2. The average annual financial turn over during the last 3 years should be at least 20 lakh.
