1. The firm/company should have experience in supplying of Sludge/Cattle manure to Government organization/PSUs during last five years ending with 31.03.2021.
2. The firm/company should be either registered with CPWD (Hort) or well settled nursery having more than 05 years of experience in supply of Sludge/Cattle manure (ending with 31.03.2021). Supporting documents/undertaking may be uploaded.
3. The firm/company should be income tax/GST assesses. Copies of Pan Card and GST registration certificate should be uploaded with technical bid.
4. The firm/company should never be blacklisted/debarred by any Government/Ministry/PSUs. An under taking/declaration in the form of Annexure -III may be furnished with technical bid.
5. The average annual financial turn over of the company for the last 03 financial years ending with 31.03.2020 should not be less than Rs. 10 lakh. A certificate duly certified by Chartered Accountant should be uploaded with the technical bid.
