

1. Only well established florist having GST registration with proper shop located within New Delhi, connected with telephone facility should apply.
2. Specialized Florist Agencies (Having experience in cut flower supply, shall only be considered).
3. Experience of having successfully completed the following similar works of prestigious nature in Govt., during last 5 years.
  - (a) Three similar works each costing not less than Rs. 36.00 Lakh  
Or.
  - (b) Two similar works each costing not less than Rs. 54.00 Lakh  
Or.
  - (c) One similar works each costing not less than Rs. 72.00 Lakhs.
4. For the purpose of similar work means supply of cut flowers successfully in prestigious Govt. Organization.
5. The average annual financial turnover during the last 3 years should be at least Rs. 1 crore.
