

- (2) Unless otherwise specified in the Scheduled of Quantities, the Rates of all the items of the work shall be considered as inclusive all charges like Transportation, Royalty and other Taxes etc.
- (3) Conditional quotation in any form will not be accepted.
- (4) The Contractor shall take instructions from the officer-in-charge regarding supply of Tractor one day in advance of actual delivery at Rashtrapati Bhavan.
- (5) The entry of Supplied of material into the President's Estate is through temporary entry passes to be made by the Security Office of the Rashtrapati Bhavan for which the contractor shall submit the details in advance along with valid identity proof and 02 Nos. Passport size Photograph.
- (6) The Department shall be at liberty to discontinue/cancel agreement by serving one-week notice without assigning any reason thereof. Decision of the OSD (Hort) shall be final and binding to the Contractor for which no claim on any account shall be entertained by the department.
- (7) No compensation shall be payable to the Contractor for any damage caused by natural calamity (Rains ,storms, earthquakes and other calamity) during the execution of work.
